Call to Order

- 1. Mayor Sydney Wiley called the meeting to order at 7:03
- 2. Roll call conducted. All council members present. Two visitors were welcomed.

Treasurer's Report

- 1. Stacy Mills presented the claim warrants and utility billing figures for June and July.
- 2. Budget and expenditure reports were distributed for review ahead of the upcoming budget meeting.
- Motion to approve claim warrants was made by council member Saari and seconded by Councilmember Walsh. Motion approved and passed unanimously.

Public Works Report

- 1. Bo Danysh reported on water usage, reservoir status, animal control coordination, and code enforcement (high weeds, dry grasses).
- 2. Discussion on asphalt patching, gravel needs, and equipment repairs.
- 3. Council discussed the impact of recent repairs and the need to replace old cast iron pipes.

Visitor Comments

- Carla Williams inquired about weed spraying and raised concerns about sinking ground where cable work was done last year. Mayor Wiley to follow up with the company.
- 2. Carla Williams opened a discussion about an illegally parked dump truck; she contacted the sheriff's department.
- 3. Lauren Baugh (Crazy Mountain Ranch) addressed water rights, community relations, and offered to answer questions. Discussion followed regarding water monitoring, legal matters, and community impact.
- 4. Speeding concerns near the school were discussed; CMR open to solutions.

Planning, Zoning, and Subdivision

- 3. Discussion on subdivision review steps and application process.
